*Vendor ID (VID) Number.* The company set forth above hereby applies for a USB Vendor ID Number and agrees to the following: The USB Implementers Forum is the authority which assigns and maintains all USB Vendor ID Numbers. Each Vendor ID Number is assigned to one company for its sole and exclusive use, along with associated Product ID Numbers. They may not be sold, transferred, or used by others, directly or indirectly, except in special circumstances and then only upon prior written approval by USB-IF. Unauthorized use of assigned or unassigned USB Vendor ID Numbers and associated Product ID Numbers are strictly prohibited.

*Annual Membership.* The \$4000 payment is a membership subscription fee for a 12-month period. Company grants permission to be named and listed as a member of the Forum in directories and marketing materials.

*Licenses.* No license is granted by virtue of membership in the Forum to any patent, copyright, or trademark.

*Generic Terms.* The Forum takes the position that the terms “USB,” “Hi-Speed USB,” “Wireless USB,” “USB 2.0,” and “Universal Serial Bus” when used in connection with any USB device are generic (collectively the “Generic Terms”). *Confidentiality.* Draft specifications and other documents are provided to the USB-IF membership on a “USB-IF Confidential” basis, and shall be maintained and safeguarded by members as confidential, until formally approved by the Forum for public release.

Neither the Forum, any Forum member, nor any other supplier of software, hardware, or services will be liable to Company for any fault or defect in these items or for any failure to deliver all or any portion of these items.

*Liability Limited.* IN NO EVENT SHALL MEMBERS OR THE FORUM OR THEIR SUPPLIERS BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, PUNITIVE, OR LOST PROFIT DAMAGES, OR FOR ANY DAMAGES ARISING OUT OF LOSS OF USE OR LOSS OF DATA ARISING OUT OF PARTICIPATION IN FORUM EVENTS, OR THIS AGREEMENT.
